INVITATION

Dear Sir,

First of all I on behalf of TFI wish you a very Happy & Prosperous New Year 2023.

Before I on behalf of TFI invite you in the **39th NATIONAL JUNIOR KYORUGI TAEKWONDO CHAMPIONSHIP & 12th NATIONAL JUNIOR POOMSAE TAEKWONDO CHAMPIONSHIP: 2022-23** would like to make you aware about the real facts behind the election of TFI and our locus standi as under,

In W.P. No. 11674/2019 under which the Hon'ble High Court of Delhi passed consent order on 28.04.2022 for conduct of election of TFI. In this Writ Petition there were two TFIs i.e. Respondent No. 3 (Fake TFI) and Respondent No. 16 (our TFI). The Hon'ble High Court of Delhi has already observed in this case in its order dated 17.02.2020 as "*The executive Committee elected pursuant to orders of this court comprised of Mr. Chetan Anand as its President and presently Mr. D.N. Pangotra is its President*".

The Hon'ble High Court of Delhi has not ordered for election of any of both the TFIs i.e. Respondent No. 3 (R-3) and Respondent No. 16 (R-16) rather ordered for election of TFI only i.e. creation of another TFI which is substantiated by the orders dated 28.04.22 read with orders dated 11.07.2022 and 23.08.2022 of the Hon'ble High Court of Delhi (Copy of orders are enclosed). Thus no election of our TFI / R-16 has been conducted.

It is also not clear that according to which constitution of TFI the election of TFI was conducted by the Hon'ble Returning Officer on 14.11.2022 as both the TFIs (Respondent No. 3 & 16) have its own different constitution and the Returning Officer had neither asked constitution from us nor mentioned in the proceeding as well as in the order of the Hon'ble Court Commissioner cum Returning Officer regarding adoption of constitution. While we had requested the Hon'ble Court Commissioner cum Returning Officer on 01.07.2022 just before starting the process of election to decide

the preliminary issue as to for which TFI the election is going to be held, but unfortunately our representation was not heard.

We tried a lot for a clear order/ direction from the Hon'ble High Court of Delhi but we could not get it because of non-cooperation from R-3. Since we are not satisfied with the election process and its result, we filed Writ Petition before the Hon'ble High Court of Delhi for justice. Moreover, our several members have already challenged the impugned consent order dated 28.04.2022 through **LPA No. 509/2022** much before the election of TFI and is pending. Till the end we participated in the election to keep protesting against the illegality being perpetuated.

Further, neither this Hon'ble Court has restrained us from functioning as TFI nor our TFI members had resolved to go with this new TFI and to dissolve it for the same. Rather this Hon'ble Court directed the IOA/ Respondent No.2 in its order dated 11.07.2022 to refund if any amount remains unspent to R-16 i.e. our TFI after completion of the election of TFI and accordingly we have asked the IOA for refund if any.

Point to be noted that it is our TFI of which Adhoc Committee was formed on 12.07.2019 by the IOA to replace it with new society and it is also our TFI which represents the original TFI of which the affiliation with World Taekwondo and IOA remained in force without any break since 1979 and 1985 respectively to till Dec'2019 when World Taekwondo derecognized this TFI after granting affiliation to India Taekwondo and accordingly the IOA also in its General Assembly on 30.12.2019 decided to grant affiliation to India Taekwondo in which reinstatement of our TFI is yet to be done as per mandate of IOA General Assembly.

Hence, under the above mentioned facts and circumstances we are conducting the activities until reinstatement of TFI is done into India Taekwondo.

I am happy to inform that UTTAR PRADESH TAEKWONDO ASSOCIATION, under the aegis of TAEKWONDO FEDERATION OF INDIA, is organizing **39th NATIONAL JUNIOR KYORUGI TAEKWONDO CHAMPIONSHIP & 12th NATIONAL JUNIOR POOMSAE TAEKWONDO CHAMPIONSHIP: 2023** from 27th to 29th January 2023 at Sacred Hearts School, Karanpur, Izzat Nagar, Bareilly, Uttar Pradesh – 243122.

I cordially invite you and your teams to participate in the Championship. The championship is for Junior Boys & Girls aged between 15 & 17 Years based on the year 2022. Only One Entry (Player) is allowed in each Category of Kyorugi & Poomsae Championship from an Affiliated State Associations / Central Organizations / Adhoc Committees.
